2) In 2003, the data capture rate for Edinburgh Centre was low (under 50%). The 2003 data for Edinburgh are therefore unreliable and will not be included in any charts or tables. The 2003 value for Edinburgh is: PM_{10} : mean = 25. The site stopped recording on the 13th of October and the monitor was then relocated to an urban background site at Edinburgh St Leonards, which started recording on 24 November 2003.
